As UF's public health liaison, I search for relevant literature and oversee UF's information collections in all sub-disciplines of public health (e.g. epidemiology, health economics). This project encompasses both knowledge/skill enhancement and presentation of the unique browsable web portal and searchable database of public health data sets that we have created at UF. Effective searching enables UF faculty to make quality contributions to solid knowledge bases for various health decisions. The unique classes in this project offer chances to further refine skills. The data set collections we have created reduce time/labor barriers to identifying useful datasets for Precision Public Health, a new method of research that integrates data from varied sources to identify and explore associations between risk factors, health care services and health conditions.

#### GOALS FOR FEO:

- 1. The past decade's trend toward evidence-based practice has increased demand for "evidence syntheses." These include systematic reviews and other advanced literature reviews that involve comprehensive searches for and carefully analyzed summaries of scientifically rigorous research. Librarians actively advise on and participate in these projects. My first goal is to enhance librarian understanding of various methodologies and software and increase skills in searching for and managing the literature that forms the foundation of such research, thereby increasing research quality and the institution's reputation.
- 2. Interest in the economics of health has increased since passage of the Affordable Care Act in 2010. My second goal is to increase librarians' basic understanding of the underlying concepts, leading to improving their efficiency and effectiveness in providing comprehensive, relevant search results on this newly emerging topic. Such results will provide depth and breadth for researchers' and students' contributions to the knowledge base upon which practice and health decisions are based.
- 3. Identifying the varied data sets used in Precision Public Health (PPH) research can be very time consuming. To free researchers for analysis, librarians at UF have identified potentially useful data sources. Public health professionals who have seen the resulting browsable list (the UF PPH LibGuide) have recognized the tool's potential to save time. Presenting the LibGuide and the soon-to-be-released the UF PPH data catalog (searchable database of indexed contents and metadata on publication date, formats, etc.) will provide a model for other librarians and interested public health professionals to consider using or adapting
- 4. Knowing of my interest in library support for public health systems, a librarian at Oxford University invited me to learn how this transpires in the UK. Traveling to the UK for the unique systematic review and health economics classes would facilitate this while providing a natural venue for giving UF's PPH data resources their first international exposure.

# Identifying Evidence for NICE Economic Submissions 05 September 2019

Health economics evidence is a key element in much health services research and particularly in health technology assessments. Identifying economic evidence to inform such research can involve searches in a range of databases and using a variety of strategies. This study day will include a 'jargon buster' session on the basics of health economics and economic models. It will also feature presentations about key economics information resources including the CEA Registry, and explorations of options for searching to identify data for economic models. With the closure of key economic evaluation databases (NHS EED and HEED) we will be focusing on how to identify economic evaluations from major bibliographic databases. There will be opportunities for hands-on practice.

# Advanced Search Techniques for Systematic Reviews, HTA and Guidelines 24 September 2019

Extensive literature searches are the foundation of high quality systematic reviews, health technology assessment (HTA), guideline development and other major projects. Conducting searches to retrieve research evidence from databases and other resources requires a range of knowledge and skills. There are constant challenges to keeping up-to-date with new database features and approaches to achieving efficient searches. Search approaches may need to be adapted depending on the end-product which the search is informing and the resources available. Search approaches increasingly need to be explained to sponsors and other end-users in terms of the extent to which they are fit-for-purpose.

This workshop will provide opportunities to learn new techniques, to discuss best approaches, to share insights and to assess variations in current best practice. The workshop will be facilitated by information specialists experienced in literature searching to inform systematic reviews and HTAs and in conducting research into the evidence base for information retrieval. Participants are encouraged to suggest topics / issues in advance for discussion during the workshop.

# **Advanced Search Strategy Design for Complex Topics**

# 25 September 2019

This course looks at how to design complex search strategies and complements our training on advanced search techniques. As the volume of published research grows it is becoming more challenging to identify efficiently studies performed according to specific methods or relating to broad topics. As well as increasing volumes of research, many research topics are complex and challenging to capture in search strategies. Examples of complex topics may include, but are not limited to, reviews of complex interventions, reviews requiring the identification of study designs other than RCTs, public health and social care topics, veterinary literature, food and feed safety research.

Information professionals and others wishing to develop search strategies for complex topics face challenges in designing strategies which retrieve relevant material but are also efficient in numbers of records retrieved. As well as approaches to developing strategies to run in traditional bibliographic databases, increasingly text analytical software and text mining techniques are being used to interrogate large literatures. These techniques can be used to identify concepts in complex topics and assist with developing strategies to capture complex topics.

This training event will address the challenges of developing search strategies to capture complex topics in large bibliographic databases using different conceptual combinations and search techniques. The training event will also introduce textual analytic and text mining techniques to demonstrate their potential for strategy design and testing. Participants will undertake exercises using open source visualisation tools to investigate terms within sets of records, in order to explore the value of text mining tools in their own future search strategy design.

# Software to Support the Systematic Review Process 26 September 2019

Systematic reviews can be time consuming, logistically challenging and labour intensive. These and other challenges have led to the development of various special-purpose software tools to support the systematic review production process. Such tools extend beyond the scope of more established general-purpose systems (e.g. reference managers, word processors and spreadsheet packages), which are already in wide use and, instead, aim to provide tailored support for particular review activities or the whole systematic review production process.

This workshop will provide an opportunity to learn about special-purpose software tools currently available to support systematic reviews and to share experiences of using software in practice. The workshop will examine and provide hands-on with both commercial and not-for-profit systematic review management packages (including Covidence, DistillerSR and EPPI-Reviewer), as well as a range of free and commercial tools to tackle single tasks within the systematic review process (such as Rayyan, RobotReviewer and SWIFT-Review).
